



## Texas Arts & Crafts Fair Official Poster Competition

- All Texas artists of traditional media (oil/acrylic/tempera, watercolors, illustrations, prints) and of computer graphics are invited to participate in this annual competition! All submissions must include the “Texas Arts & Crafts Fair” logo, fair dates Sept. 28, 2019 10 a.m. – 5 p.m. & Sept. 29, 2019 10 a.m. - 4 p.m. and location: Hill Country Arts Foundation, Ingram, Texas. The fair website URL also must be included: [www.txartsandcraftsfair.com](http://www.txartsandcraftsfair.com) but it is optional to include the words: “Since 1972 Texas’ official state arts and crafts fair.”
- Entrants must be over 18 years old and provide proof of Texas residency.
- Each entry must be a completely original concept.
- The poster design and elements will be used in official Texas Arts & Crafts Fair merchandise. Artists are encouraged to keep in mind the merchandising flexibility of the content of their original artwork.
- Submit your work digitally in a vertical poster format that would measure 24” wide by 36” high.
- **Deadline for submissions will be 5 p.m. Jan. 31, 2019. Entries will accepted Jan. 1-Jan. 31 ONLY.** Entries should be uploaded as PDFs and sent to [fair@hcaf.com](mailto:fair@hcaf.com), subject line: poster contest. Submissions should include artist’s name, email address, mailing address and phone number(s). o The winning artist will receive \$500 and a free booth at the fair. The winner will be introduced Feb. 18, 2019 at the Texas Arts & Crafts Fair poster unveiling event at the Hill Country Arts Foundation in Ingram, Texas. Additionally, the winning artist will be recognized in media releases.
- The Texas Arts & Crafts Fair may ask the winning artist to make changes to the artwork before the poster is printed.
- The Texas Arts & Crafts Fair will retain ownership and full copyright of the winning poster and its reproductions. The Fair will adapt elements of the poster for use on other official Fair merchandise. The Fair will retain ownership of the original poster artwork and may reproduce, in whole or in part, the artwork with no additional consideration to the artist. Any use or adaptation of the artwork is within the sole discretion of the Fair.
